#### ORDINANCE NO. 91 - 214

#### AN ORDINANCE DESIGNATING THE THOMAS CLOW PROPERTY LOCATED AT 11236 SOUTH BOOK ROAD AS A HISTORIC LANDMARK

WHEREAS, Section 6-11-3 <u>et seq.</u> of the Municipal Code of the City of Naperville provides the opportunity for the Naperville Historic Sites Committee to recommend designation of certain buildings which are located within the corporate limits and may have historic significance as landmarks; and

WHEREAS, in conformance with the rules and regulations of the Municipal Code of Naperville the Historic Sites Commission held a public hearing on the designation of a stone building on the Thomas Clow property located at 11236 South Book Road as a historic landmark; and

WHEREAS, the Historic Sites Commission found the stone building on the Thomas Clow property located at 11236 South Book Road meets the criteria for the designation of landmarks as set out in Section 6-11-3:2 of the Municipal Code of Naperville; and

WHEREAS, the Historic Sites Commission unanimously recommended on September 26, 1991, that the subject building be designated as a landmark; and

WHEREAS, on October 15, 1991, the Mayor and City Council of the City of Naperville accepted the Historic Sites Commission's recommendation that the stone building on the Thomas Clow property be designated as a landmark. NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NAPERVILLE, DUPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule powers, as follows:

<u>SECTION 1</u>: The stone building on the Thomas Clow property located at 11236 South Book Road be and the same is hereby designated to be a historic landmark.

<u>SECTION 2</u>: That this Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.





A District of Columbia court stated in 900 G Street Associates v. Department of Housing and Community Development, 430 A.2d 1387 (1981):

The basic question presented in this case is: at what juncture does the diminishment in value allegedly resulting from the governmental restriction on the use of property constitute an "unreasonable economic hardship" to the owner, which is here synonymous with an unconstitutional "taking"? . . (I)f there is a <u>reasonable</u> alternative economic use for the property after the imposition of the restriction on that property, there is no taking, and hence no unreasonable economic hardship to the owners, no matter how diminished the property may be in cash value and no matter if "higher" or "more beneficial" uses of the property have been proscribed.

#### WITNESSETH:

the rights-of-way adjacent to the Subject Property in accordance with CITY ordinances. Said sidewalk installation shall be at no cost to the CITY and same shall be constructed by OWNER upon the City Engineer giving written direction to OWNER to construct same.

#### 15. ROUTE 59 IMPROVEMENTS.

OWNER and DEVELOPER hereby agree to dedicate, at no cost to the CITY, enough land to provide for sixty (60) feet of rightof-way from the center line of Rt. 59 to that portion adjacent to the Subject Property.

#### 16. HISTORIC SITES.

It is understood by the parties hereto that the City of Naperville Historic Sites Commission is, upon annexation of the Subject Property, desirous of reviewing the stone home located thereon. OWNER and DEVELOPER hereby agree to cooperate in any reasonable way in order to provide for the review and investigation of said building.

#### 17. MODEL HOMES.

The CITY agrees to permit DEVELOPER to construct, maintain and utilize as model homes single-family models on any three lots of the Subject Property not finally platted, in advance of any plat approval, but only after construction and acceptance of sanitary sewer and water mains for such model units, and construction of a hard-surfaced roadway (defined as a minimum 2.0 structural number with a binder course) to and adjacent to the model area, provided that no such construction shall prejudice the power and right of the CITY to review, approve and disapprove final

The Landmarks Preservation Council of Illinois (LPCI) is a private, non-profit organization dedicated to preserving historic architecture in Illinois. We are well aware of Naperville's progressive record in historic preservation and urge you to reinforce that record by designation of the Boris House and the Thomas Clow farmstead landmarks.

The Clow farmstead provides a comprehensive and remarkably rare look into the pioneering agricultural history of the Midwest. With three farmhouse structures dating to the period of first settlement, the Clow farmstead is a unique opportunity to preserve and interpret the early history of Northeastern Illinois. The two houses and barn provide a more complete picture of nineteenth century agriculture than can be found in most of the region.

The progression from wood to stone house illustrates the incredible growth that the rich prairie soil of Illinois made possible for the settlers. The construction techniques themselves are instructive as to the tools, methods, and transportation systems of the day. The locally quarried limestone is of great interest, since few buildings made from this indigenous stone survive. LPCI has published a technical book regarding the preservation of Illinois' dolomite stone, rarely used after 1890.

The relationship of the original home, the stone house, and the brick-floored barn provides a unique context for understanding how farms of the period operated, and how the area was settled. The relation of the buildings to the DuPage River, to the local quarries, and to the rich farmland itself should be preserved, for this context is a vital key to understanding our past.

The fact that these buildings survive is extremely fortunate for Illinois. While the subdivision of the lands surrounding the buildings may be inevitable, the preservation of these buildings can be accomplished without sacrificing the gains of new development.

Landmark designation will assure that the public interest in these rare resources is considered, indeed, the Clow farmstead will grant a special character to the

Attached as photographs 1 and 2 are 8" X 10" enlargements of the 1953-1954 aerial photographs of the Durant-Clow-Boris 1844 and Thomas-James Clow 1859 farmsteads as they appeared on page 538 of reference Drury 1955. These photographs illustrate these farmsteads during their active and productive tenure for which they were conceived, constructed, and operated.

These two (2) farmsteads are particularily notable within the early and formative agrarian society and culture of Wheatland township in the mid 1800s in that the

> Durant-Clow-Boris farmstead embodies one of the oldest stone houses (1844) as well as contained the oldest stone and timberframe barn (1859), and the Thomas Clow (11 July 1829 - 7 September 1893) farmstead contains the premier stone house (1868) and the largest barn (1870).

Specific comments concerning each individual photograph and corresponding farmstead follow.

#### DURANT-CLOW-BORIS 1844 FARMSTEAD

Photograph 1 is an accurate representation of the Durant-Clow-Boris farmstead during its prime period of operation (about 1850-1970) with the exception of the absence of the windmill and tower (Hutcherson and Lambert 7 August 1991). As is evident,

this farmstead was composed of

Two (2) houses, the

1844 stone one (marked building Amin photograph 1), and also a

Wood frame one (building B), the

1859 stone and timberframe barn (building D), a Large corn crib (building E),

Large garage and storage building (building F), and Many attendant buildings which included the former

chicken house - now tool shed (building C).

The number and size of the various trees within the farmstead is a good indicator of the longevity of tenure of this farmstead.

#### 1844 Stone House, Quarry, & Related Stone Buildings

Keep in mind that this 1844 stone house (building A in photograph 1) shares the notarity of being the oldest stone house (and structure) within Wheatland township with the

> First portion of the Mather house located in section 23 on the west side of Plainfield-Naperville Road just south of lllth Street, and the Stone barn and ice house on the Robert Clow (30 April 1787 - 5 October 1870) farm which is now owned and operated by William F. Clow and located in section 15 in the southwest corner of Book Road and 103rd Street.

Also be aware that the limestone quarry located directly north of the Durant-Clow-Boris 1844 stone house in section 11 across 104 Street, Figure 1, was the source of the limestone for at least ten (10) of the earliest known stone structures build within Wheatland township as the

> Durant-Clow-Boris 1844 stone house, First portion of the Mather 1844 stone house, Robert Clow (1787-1870) 1844-1845 stone barn and ice house,

Stone foundation in the Robert Clow (1787-1870) 1840's barn,

- Stone foundation in the Mungo Patterson (22 September 1814 - 16 July 1906) house (later the Boughton and now Meisinger house in section 11 on Book Road just north of 103 Street) which was build in twenty six (26) days (Monday 9 June 1845 - Saturday 5 July 1845) (Patterson 1977 (Mungo Patterson diary, pages 96 - 97)),
- East Wheatland 1850 1855 creamery that was demolished by William G. Haider (Mid America "Development" Services (MADS)) on or about March 1989 (further described in Hutcherson 7 August 1991 A and B),
- Stone base in the Durant-Clow-Boris 1859 stone and timberframe barn that was demolished at the direction of Paul Hoffman (Oliver - Hoffman Corporation (OHC)) and Robert Kropp (OHC) on Tuesday 6 August 1991, Stone foundation in the Thomas Clow (1829 - 1893) 1859

original wood frame house,

Most of the Thomas Clow (1829 - 1893) 1868 house (Hutcherson and Lambert 7 August 1991 A) with the exceptions of the quoins on the edges of the walls and the exterior stairs and porch floor plates of the house which are Lockport limestone, And most probably many more buildings in Wheatland township that are not known of and/or been

removed without any knowledge of their existance or source of their building materials.

Furthermore, 104 Street is located one-eighth (1/8) of a mile south into section 14 rather than on the east-west section line between sections 14 and 11, Figure 1, because the foregoing limestone quarry existed and was in use before 104 Street was constructed (Patterson 1977 (Mungo Pat**terson** (1814-1906) diary, pages 93-104); Boughton 1963 (Robert Clow (1819-1888) diary, page 8)).

Based on the foregoing, it would logically follow that if the foregoing minimum of ten (10) historic stone buildings are of merit to landmark for historic preservation purposes, then the one single quarry from which came the limestone for all ten (10) of these buildings, and perhaps more, has equal or more merit on which to be landmarked for the same historic preservation purpose!

#### 6 August 1991 Demolition of Buildings

As a remorseful thought, on Wednesday 7 August 1991 (the first day this property was incorporated into the City of Naperville, Illinois), the only buildings of this once **pi**oneer, prosperous, and model farmstead of early agrarian society and culture in Wheatland **t**ownship were the

> 1844 stone house (building A), the Wood frame house (building B), the Garage and storage building (building F), and the Tool shed (building C).

All the remainder of these buildings were demolished on Tuesday 6 August 1991 at or about 4:30 pm (only about three (3) hours before the land on which these buildings reside was annexed into the City of Naperville) at the direction of

Paul Hoffman (OHC),

Robert Kropp (OHC), and

Adcock Construction (or more aptly "Destruction") as further detailed in Hutcherson 7 August 1991 B.

#### THOMAS-JAMES CLOW 1859 FARMSTEAD

Photograph 2 is an accurate representation of the Thomas (1829-1893) - James (10 April 1863-15 November 1942) - James H. (2 January 1914) Clow farmstead during its period of operation (about 1868-approximately 1976). As is evident, this farmstead

consisted of

Three (3) house, the

Original 1859 wood frame one (marked as building A in photograph 2 - largely hidden by the trees) that the Clow-family lived in from at least 1859 to the building of the 1868 stone house, 1868 stone house (building C), and also a 1913 wood frame one (building B), the 1870 stone and timberframe barn (building D), Three (3) large, tall silos, and

Many attendant buildings (machine sheds, grain bins, etc). The number and size of the various trees within the grove to the south and west of the farmstead is a good indicator of the longevity of tenure of this farmstead. An 1880-1885 photograph of this same farmstead (Hutcherson and Lambert 7 August 1991 A) clearly illustrates the same grove as shown in photograph 2 when it was first started. Trees such as those in the grove illustrated in photograph 2 did not exist on the prairie away from the Dupage River prior to the surveying (1837-1838) and U.S. Congress Pre-Emption (or homesteading) Act of 1841 (from which the Naperville Pre-Emption House (or land transaction office) gets its name) which made the land in Wheatland and surrounding townships available for private ownership (Patterson 1977, page 93-104; Boughton 1963, page 8; Will County History 1878). Hence, the trees shown in photograph 2 had to be planted. And may of these trees are the pines that the homesteaders brought with them from Scotland via New York state and perhaps elsewhere which were not native to northern Illinois.

#### 1859 Wood Frame House

Probably the most historic building of this farmstead from a longevity viewpoint is the 1859 or earlier wood frame house, building A, that the Thomas Clow (1829-1893) family lived in prior to the building of the 1868 stone house. This building

is now configured as a small "barn" or ancillary building with "lean-tos" added to both its west and east sides. This particular building was most probably build no later than the fall of 1859 (no building was typically done in the fall and winter) because

Belle Wilson Clow (<u>26 April 1860</u> - 21 December 1945), James Clow (<u>10 April 1863</u> - 15 November 1942), and various other children of Thomas Clow (1829-1893) and wife Margaret (Stephens) Clow (4 August 1829 - 29 July 1892) were born in this house (Clow 1991). Also, the 1860 U. S. Federal Census plat may, Figure 1, shows a dwelling existing no later than 1860 at the current location of the Thomas Clow (1829-1893) farmstead.

### 1868 Stone House

As previously indicated, the 1868 all stone house build by "F. EFFTING - MASON" is unquestionably the premier architectural, all stone house in Wheatland township and the Stone Building District of Wheatland and Plainfield townships.

Most of the stone for this house was <u>sledded down the frozen</u> <u>Dupage River</u> from the quarry on the section line between sections 11 and 14, Figure 1. The ornamental stone (quoins at the edges of the walls, etc) and the porch and front steps floor plates came from the Lockport quarries.

The two (2) chimneys on the two (2) story portion of the stone house were removed apparently between about 1953-1954 and approximately 1980.

The large trees in front (on the east side, photogragh 2) of the stone house were removed apparently in approximately the same period.

### 1870 Stone & Timberframe Barn

The 1870 stone and timberframe barn which measures approximately 42' wide, 45' high to the gable of the roof, and

110' long

is a large, multi-purpose structure (house animals, had a dairy section, store grain, hay, machinery, etc) with a brick floor throughout most of the building. There is a hay loft extending the full length of the barn. As previously mentioned, its stone foundation came from the quarry on the section line between sections 11 and 14, Figure 1.

This particular barn is the

Largest remaining barn in Wheatland township, Is most in good structural condition, and

Is an excellant example of the timberframe (post and beam) style of construction of large buildings in Wheatland and surrounding townships in the mid 1800's.

# Consequently, this barn should definitely be landmarked for historic preservation purposes!

The three (3) concrete silos as well as the surrounding farm buildings illustrated in photograph 2 were demolished and removed from this property by Kenneth Koranda (Mid America) Federal Savings and Loan - parent company of MADS) on or about March 1989 during the period Mr. Koranda owned this property.

In addition, the only limestone that remains from the East Wheatland 1850-1855 creamery is located in a pile of rubble west of the 1859 wood frame house (building A in photograph 2) on the Thomas-James Clow farmstead (Hutcherson and Lambert 7 August 1991 A, photograph 14). This material is located here because MADS owned at the same time both the property containing the creamery (the 80 A of the Crego farm in Wheatland township, section 24, south of 111 Street and east of Essington Road) as well as the Thomas-James Clow farmstead. And MADS trucked the rubble from the creamery March 1989 demolition to the Thomas-James Clow farmstead to remove it from the section 24 site to try to clean up their demolition on this site as well as make it more saleable (ultimately to Boughton Quarry and Trucking Company and Allyn K. Bronk on or about 20 Jung 1990 for farm use as it was when Cregos owned it before MADS acquired it).




