\* NOTICE: This registration is part of a pilot program that will authorize registered motorcycles to be parked in the appropriate commuter permit parking lot from June 15, 2009 through November 30, 2009. For each commuter parking permit issued, only one motorcycle license plate number may be registered. Following review of this registration form, you will be notified of approval. Once registered, the registered motorcycle must be parked in the same lot for which a commuter parking permit has been issued. The commuter identified on this registration will be considered the motorcycle user and the responsible party. Unauthorized motorcycles, motorcycle parked in the incorrect commuter parking lot, or commuters with both a motorcycle and personal vehicle parked in the commuter lot on the same day will be ticketed. The city reserves the right to suspend or terminate the program at any time and will notify you of any changes to the program at the email address provided.
