# INSTRUCTIONS FOR REQUIRED NOTICE

## **Sign**

A sample public hearing sign is provided on **Attachment 1**. Prior to posting a sign on the subject property, please complete the empty fields on **Attachment 1** and submit a draft to City staff for review and approval. Upon receiving staff approval, the sign must be posted on the subject property *at least 15, but not more than 30 days*, prior to the public hearing date in a location easily visible from the public right-of-way. Questions regarding the sign text and/or placement may be directed to the assigned project manager at [DRT@naperville.il.us](mailto:DRT@naperville.il.us)

## **Written Notice**

A sample letter providing the required "Notice of Public Hearing" is provided on **Attachment 2**. Prior to sending this letter, please insert information into the required information fields on the applicable attachment and submit a draft to City staff for review and approval. Following staff approval, this letter must be sent by first-class mail or hand-delivered\* to the owners of record of all lots within 300 feet (inclusive of the public right-of-way) of the property lines of the subject property; said notice must be given *at least 15, but not more than 30 days*, prior to the meeting date. Names and addresses of owners of record may be obtained from the local township assessor's office. Questions regarding the content of the letter and/or notice requirements may be directed to the assigned project manager at [DRT@naperville.il.us](mailto:DRT@naperville.il.us).

\* If the letters are hand-delivered, the Petitioner shall maintain a log signed by the individual receiving the letter to verify that notice was received (see **Attachment 3** for signature log).

## **Notice to Cable Providers**

An email notice shall be provided to the three cable providers listed below at least 15 days prior to the public hearing date. The notice shall include **the location and a description of the project** and include the following language: "You are receiving this notice of development application in accordance with your Franchise and/or License Agreement with the City of Naperville which requiring notification of annexation, construction or development where cable system extension is possible."

**Affidavit**

- Written comments received after 5:00 p.m. the day before the meeting will be added to the case file.

### **Speaking during the meeting, or public hearing, if applicable:**

- Individuals who wish to speak must be present in-person in City Council chambers at 400 South Eagle Street, Naperville.
  - Appropriate COVID-19 safety protocols will be followed in City Council Chambers. Information can be found on the City's website and at the Naperville Municipal Center.
