

Executive Summary

AP-05 Executive Summary - 91.200(c), 91.220(b)

1. Introduction

The City of Naperville is a Community Development Block Grant (CDBG) entitlement community as defined by Title I of the Housing and Community Development Act of 1974. Naperville receives an annual block grant that can be used to address critical and unmet community needs, including housing rehabilitation, public facilities, infrastructure, economic development and public services.

On March 27, 2020, President Trump signed the Coronavirus Aid, Relief, and Economic Security (CARES) Act, Public Law 116-136. The CARES Act allocated \$5 billion in supplemental Community Development Block Grant (CDBG) funds to prevent, prepare for, and respond to the coronavirus (COVID-19) pandemic. Of the \$5 billion, the U.S. Department of Housing and Urban Development (HUD) allocated \$2 billion directly to entitlement communities. These supplemental funds are referred to as CDBG-CV funds.

The City of Naperville's CDBG-CV allocation is **\$315,985**. In addition to the CDBG-CV funds, Naperville has **\$81,000** in Program Year (PY) 2019 entitlement funds available for reprogramming from two projects that requested cancellation. This gives the City a total of **\$396,985** to use to alleviate the effects of the public health crisis.

2. Summarize the objectives and outcomes identified in the Plan

The Substantial Amendment aims primarily to address the needs of low- and moderate-income Naperville residents and to mitigate the negative effects of the COVID-19 public health crisis on the community. The City's primary goal is to support basic needs – housing and food security, with an emphasis on vulnerable citizens – seniors, people with disabilities, and people who may have lost employment or income due to the pandemic. Funds will be used to support a variety of public services, enabled by the elimination of the 15 percent public service funding cap. Programs to be funded are summarized below:

- Public Services: Program assistance to individuals, households and businesses
 - \$ 50,000 Shelter: Up to 3 months of rent/mortgage/utility assistance to households
 - \$ 50,000 Shelter: Motel/hotel expenses for domestic violence and homeless persons
 - \$ 60,000 *Food:* Meal preparation and delivery to seniors and people with disabilities
 - \$ 76,935 Other Public Services: Employment, mental health, childcare,etc.
- Economic Development: Assistance to small businesses

\$100,000 Small Business Assistance: Assistance to enable job creation/retention

- **<u>Public Facilities</u>**: Assistance to nonprofits for capital improvements and costs associated with preventing, preparing for and responding the impacts of COVID-19
 - \$ 60,000 *Housing/Services:* Assistance to group homes/CILA's, transitional housing, etc.

3. Evaluation of past performance

Naperville has a large nonprofit social service community with experience in providing public services to Naperville residents. Several agencies have extensive experience as CDBG grantees or grantees receiving local funding from the City of Naperville. Collectively these agencies provide services to hundreds of Naperville residents each year.

4. Summary of Citizen Participation Process and consultation process

To prepare the Amendment, staff consulted with over 30 nonprofit agencies and government departments to gain an understanding of community needs in response to COVID-19. Organizations consulted included nonprofit agencies that previously received Naperville CDBG and Social Services Grants (SSG); local economic development organizations, City commissions and task forces, City departments, other entitlement communities, HUD and City Council.

The Citizen Participation Process is conducted according to public participation policies and procedures detailed in the City's Citizen Participation Plan. The Plan was amended to allow for virtual public hearings and expedited procedures allowed by HUD to speed the delivery of CDBG-CV funds. A public comment period for the PY 2019 CDBG-CV Substantial Amendment will begin on July 17, 2020 and will conclude on July 21, 2020 with a public hearing at the July 21st City Council meeting.

Introduction

On April 2, 2020, the City of Naperville received official notification from the U.S. Department of Housing and Urban Development that it would receive a special allocation of CDBG funds in the amount of \$315,985. These funds were authorized by the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) to prevent, prepare for and respond to the COVID-19 pandemic. In addition, the City will reprogram \$81,000 in regular CDBG entitlement funds originally awarded to projects that will be cancelled at the request of the subrecipients.

Describe the reasons for allocation priorities and any obstacles to addressing underserved needs

The allocation priorities respond to quantifiable increases in need due to the effects of the COVID-19 pandemic. Funds will be used primarily to benefit low- and moderate-income individuals, households and organizations providing housing and services to homeless persons and persons with special needs. Funds will also be used to support businesses that have been negatively impacted by shutdowns and sanitation and social distancing requirements. Funding will assist them to hire and retain employees. Projects to be funded will include the following:

Public Services:

- **Rent, Mortgage and Utility Assistance: \$50,000.** Funds may be used to provide up to 3 months of assistance to a prevent homelessness by paying rent, mortgage and utility arrears for persons that have become unemployed/underemployed due to COVID-19.
- Hotel/Motel and Other Temporary Housing Expenses: \$50,000. Will primarily assist organizations serving homeless persons and victims of domestic violence who are unable to provide shelter-based housing do to COVID-19.
- Food Assistance: \$60,000. Assistance to organizations to provide Meals-On-Wheels, food preparation and delivery/pick-up programs for seniors, persons with disabilities and persons with health conditions
- Other Public Services: \$76,985. Assistance to organizations providing other services facing increased demand due to COVID-19: job counseling/training, mental health/substance abuse counseling, childcare, etc.

Economic Development:

• Small Business Assistance: \$100,000. Assistance to small businesses by providing short-term assistance with capital expenses to avoid loss of jobs.

Public Facilities:

• Housing and Services for Persons with Special Needs: \$60,000. Support to organizations providing housing or services in group homes/CILA's, transitional housing or handicapped

centers. Funds can be used to improve living conditions and reduce operating costs through capital improvements.

Discussion

A maximum of 30.0% of the City's CDBG-CV funds will be spent on Urgent Need activities that may not be targeted towards low- and moderate-income or may not require income verification. A minimum of 70.0% of funds will be expended to assist low- and moderate-income residents. These percentages will be determined based on aggregate expenditures for program years 2017, 2018 and 2019, per the City's CDBG Certification submitted in PY 2017.
