COVID-19 Community Update

Entering Phase 3

Today, most areas of the State of Illinois, including Naperville, are moving into Phase 3 of the Governor's Restore Illinois plan.

This phase includes the limited reopening of manufacturing, offices and retail and the loosening of many restrictions previously put in place to help slow the spread of COVID-19. Locally, this phase also brings with it the reopening of City Hall to the public, the end of mail-in yard waste sticker orders, and the full restoration of curbside garbage, recycling and yard waste services as of June 1. As Mayor Chirico states in today's [video message to the community](#), however, the loosening of some restrictions does not mean the threat posed by COVID-19 has ended. With the limited reopening of retail stores, barbershops and salons, state parks and other locations, an emphasis on social distancing, occupancy limits and face coverings will remain critical to maintain the progress our region has made in slowing the spread of COVID-19.

This virus remains a significant concern throughout the State, and a sustained increase in positive tests or a significant outbreak could force a region to move back to a previous phase with tightened restrictions.

Residents are still required to wear face coverings in public buildings or any time they can't keep six feet of distance between themselves and others, even outdoors. Similarly, residents are still encouraged to stay home when sick, practice social distancing and wash/sanitize their hands and frequently-touched surfaces regularly.

WHAT'S CHANGING?

OUTDOOR DINING

- Bars & restaurants can open for outdoor seating in addition to existing pick-up/delivery services
- Specific safety measures and guidelines must be followed

Phase 3

ALL RETAIL OPEN

- In-person shopping allowed
- Safety precautions & capacity limits

HEALTH CLUBS & PERSONAL CARE

- One-on-one personal training in indoor facilities & outdoor fitness classes of up to 10
- Nail salons, tattoo shops, hair braiders, spas & barbershops can open with safety precautions & capacity limits

ACTIVITIES & CHILD CARE

- Limited child care & summer programs open with safety guidance
- Youth sports may resume non-contact practices & lessons with safety precautions
- All state parks open

WHAT'S THE SAME?

FACE COVERINGS

- Required in public indoor spaces & everywhere you can't maintain 6 ft. of distance
