Executive Order 2021 – 1

EXECUTIVE ORDER OF THE MAYOR OF THE CITY OF NAPERVILLE

RECITALS

1. **WHEREAS**, on January 30, 2020, the World Health Organization declared the COVID-19 outbreak to be a public health emergency of international concern; and
2. **WHEREAS**, on March 13, 2020, the President of the United States issued a proclamation on declaring a national emergency concerning the COVID-19 outbreak, and
3. **WHEREAS**, on March 9, 2020 Governor Pritzker issued a disaster proclamation for the State of Illinois due to the highly contagious and dangerous nature of COVID-19, which disaster proclamation has been extended from time to time, is currently pending, and may be extended again in the future (hereinafter “Gubernatorial Disaster Proclamation” or “Disaster”); and
4. **WHEREAS**, on March 17, 2020, at an emergency Naperville City Council meeting a local state of emergency and disaster related to the COVID-19 outbreak was declared and on April 21, 2020 at a Naperville City Council meeting the local state of emergency and disaster was extended for as long as the Gubernatorial Disaster Proclamation remains in effect (see, *Mayor of Naperville’s Declaration of a Local State of Emergency and Disaster*, *City of Naperville Ordinance 20-028 pertaining to a local state of emergency and disaster*, and *City of Naperville Ordinance 20-040 pertaining to a local state of emergency and disaster*); and
5. **WHEREAS**, on May 5, 2020, the Governor of the State of Illinois established a five-phase plan, Restore Illinois, for the reopening of the State and the Governor of the State of Illinois has determined that Naperville’s regions are currently in “Phase 4” of the Restore Illinois plan; and
6. **WHEREAS**, since the local state of emergency and disaster related to the COVID-19 outbreak was declared, I, the Mayor of the City of Naperville, have issued multiple executive orders and amendments to prior executive orders pursuant to emergency authority granted to the Mayor of the City of Naperville; and

7. **WHEREAS**, certain previously issued executive orders and provisions within certain previously issued executive orders were issued as effective until such a date as later determined, in writing, by the City; and
8. **WHEREAS**, I, the Mayor of the City of Naperville in exercise of my emergency authority have determined on behalf of the City that it is now appropriate to terminate certain previously issued executive orders and provisions within certain previously issued executive orders; and
9. **WHEREAS**, the City of Naperville is a home rule unit of local government and may exercise any power and perform any function pertaining to its government and affairs including, but not limited to, the power to regulate for the protection of the public health, safety, morals and welfare, including taking immediate emergency measures to protect the public welfare in response to the COVID-19 outbreak.

THEREFORE, by the powers vested in me as the Mayor of the City of Naperville, and pursuant to 65 ILCS 5/11-1-6 of the Illinois Municipal Code, 20 ILCS 3305/11 of the Illinois Emergency Management Agency Act, Sections 10-1-1 and 1-8D of the Naperville Municipal Code, the Mayor of Naperville's Declaration of a Local State of Emergency and Disaster and City of Naperville Ordinances No. 20-028 and 20-040, I hereby order the following:

SECTION 1: Recitals. The Recitals set forth above are found to be true and correct and are hereby incorporated herein and made part hereof in their entirety by reference as though fully set forth in this Section 1.

SECTION 2: Termination of certain previously issued executive orders. As of 12:00 A.M. on January 11, 2021, the following portion of a previously issued executive order is deemed terminated and no longer in effect:

1. **The portion of Executive Order 2020-05**, issued March 23, 2020, that imposed a moratorium on Naperville Municipal Code violations for overnight parking is hereby terminated effective January 11, 2021.

The portion of Executive Order 2020-05 that imposed a moratorium on Naperville Municipal Code violations for time limited parking and commuter lot parking violations was previously terminated effective November 1, 2020. Upon termination of the overnight parking moratorium, the entirety of Executive Order 2020-05 will effectively be terminated.

SECTION 3: Savings clause. If any provisions of this Executive Order or its application to any person or circumstance is held invalid or unenforceable by any court of competent jurisdiction, this invalidity or unenforceability does not affect any other provisions or application of this Executive Order, which can be given effect without the invalid or unenforceable provision or application. To achieve this purpose, the provisions of the Executive Order are declared to be severable.

SECTION 4: Effective date. This Executive Order shall be in full force and effect from 12:00 A.M. on the date listed atop page one of this Order.
